The Noxious Weed Bounty first started when Wallowa Resources and Rocky Mountain Elk Foundation teamed up to find new weed sites in the in the Lower Grande Ronde. Since then we have expanded the hunt to include the Imnaha River, and Wallowa Resources is now the sole financial provider.

Please review the contents of your Bounty Hunter Packet carefully in order to ensure your eligibility for a weed bounty should you locate a new site.

- Maps of known weed infestations

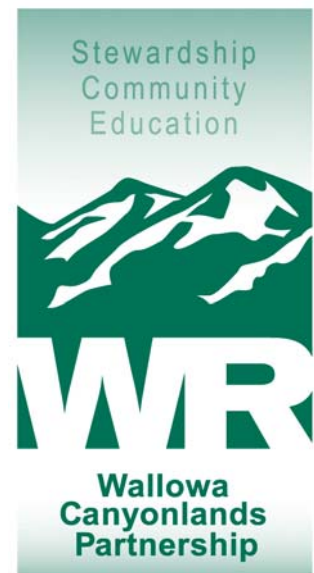

BOUNTY PROGRAM RULES

- Bounty Hunters must follow all program rules to be eligible for a Bounty award.
- A bounty award of \$200 will be awarded for the verified identification of a **NEW SITE** of one of the following seven top priority noxious weeds:
 - Rush Skeletonweed (*Chondrilla juncea*),
 - Leafy Spurge (*Euphorbia esula*),
 - Meadow Hawkweed (*Hieraceum pratense*),
 - Spotted Knapweed (*Centaurea maculosa*),
 - Whitetop (*Lepidium alba*),
 - Orange Hawkweed (*Hieracium aurantiacum*)
 - Common Bugloss (*Anchusa officinalis*).
- The new site must be located within the Wallowa Canyonlands Partnership Area to be eligible for a bounty prize (See map, attached).
- **Leafy Spurge and Common Bugloss sites must be farther than 100 yards from the high water mark of the Rivers to be eligible for the Bounty.**
- New Whitetop and common bugloss sites in the **Grande Ronde only** will be rewarded.
- No bounty will be paid until the species of weed and its presence at the site have been verified by the Program Coordinator or other approved staff (see list at end of document). The Program Coordinator or approved staff will visit the site for verification prior to awarding the bounty.
- **If there is only one plant present in a site, do not remove the plant from the site! Please do only what is necessary to stop seed production.** Report the site location to the Program Coordinator or approved staff and they will visit the site for treatment and verification. **Mark the site well**, so it can be found easily by the verifier (use flagging and/or GPS).
- For sites with more than one plant, the hunter must bring in a sample (three plants maximum) of the weed that includes enough of the plant to allow positive identification (including > 4" of root, the entire stem, a full sample of the leaf, and entire seeds and/or flowers that are on the plant at the time of finding). **The Sample must be contained in such a way as to preserve its condition and to prevent accidental spread of seed: if it is not, no bounty will be awarded!**
- No bounty will be paid for a private land weed site unless the owner confirms that you had permission to go there - before you went looking!
- The program coordinator or paid staff will keep the plant sample for proper disposal.
- There will be ten \$200 dollar awards available, five awards for weeds found in Oregon, and five awards for weeds found in Washington.
- Those employed or contracted in weed control (and their families) will NOT be eligible for bounty payments.
- Bounties will be paid on a first come first serve basis until all ten bounties have been awarded.
- For a great group activity and fundraiser for boy scouts, youth group etc..., how about getting a group of kids together to search for weeds!

HELPFUL HINTS!

Maps (available at www.wallowaresources.org) are made to help you find areas that would be good to look in – where you might find a new site. They are not made to navigate to exact points with. Ask the program coordinator if you would like more information. Some of these points are on **private land!** Do not go onto private land without permission. No bounty will be paid for a private land weed site unless the owner confirms that you had permission to go there - before you went looking!

Weeds can be hard to find and identify so pay close attention to these hints.

- Orange Hawkweed - best seen in late June and July. The only known site is at Field Springs State Park. Orange hawkweed generally likes shady areas or moist meadows.
- Meadow Hawkweed - best seen mid June to early August. Very hard to find when it is not in bloom. There are some native hawkweeds that look very much like meadow hawkweed, so study your hawkweed flier before you go looking!
- Rush Skeletonweed - is easiest to see in August and September when the grass around them dries out. Biological control agents can make the plant look different than the pictures so make sure you use the skeletonweed flier to help identify the plant correctly!
- Spotted Knapweed - is a late bloomer from late July to mid or late August. Remember that it closely resembles diffuse knapweed and can have white or purple flowers! Again, use your flier!
- Whitetop - is an early bloomer beginning in May at the low elevations and blooming through June in the higher elevations. Remember, it is a perennial plant with smooth stems and a bunch of roots! Bounties are only awarded for sites found in the Grande Ronde River Watershed.
- Leafy Spurge - is known to be scattered throughout the riparian areas of the Wallowa and Grande Ronde Rivers (NO bounty is available for sites within 100 yards of these rivers!). It is easy to see its bright yellow bloom beginning in May through July. It turns red in the fall before losing its leaves. **Remember the sap from this plant is caustic and can cause blindness – always use gloves when handling it! Take extra care to keep the sap out of your eyes!**
- Common Bugloss – is known to be in the Imnaha River corridor, but only sites found in the Grande Ronde and those upland (non riparian sites) below Fence Creek in the Imnaha will be awarded a bounty. This plant grows up to three feet tall and has small bright blue or purple flowers with a white center.

To keep your weeds in good shape carry a plastic freezer bag with you and put a slightly damp paper towel in the bag with the plant– keep cool (refrigerated) as best as possible.
